HOW CARE HOME GROUPS IN THE UK SIGNPOST OLDER PEOPLE IN THEIR CARE TO INDEPENDENT ADVOCACY

Key findings from OPAAL's review of Care Home Group websites' compliance with NICE Guidance NG227.

- It is very difficult to find a reference to independent advocacy for older people on the majority of Care Home Group websites, with the one notable exception of <u>Brancaster</u> <u>Care Homes</u>.
- It is highly unlikely that older people living in care homes, who may not know about advocacy, and in some instances may not have anyone in their life who can help them speak up about their needs and wants, will get the support they need to fully express themselves about decisions that directly affect the quality of their lives.
- The vast majority of Care Home Groups are not demonstrating that they are complying with the NICE Guidance NG227, specifically.
 "Offer advocacy to people who are not covered by the legal entitlement, but who would otherwise not be able to express their views or sufficiently influence decisions that are likely to have a substantial impact on their wellbeing or the well being of someone they have caring or parental responsibility for." [NG227 1.2.1]

OPAAL is calling upon all Care Home Groups in the UK to take the following actions:

- To provide information on independent advocacy; what it is, how it could help older people (and others), and how it can be accessed.
- Information on independent advocacy should be provided **prominently** in the places and online sites that older people, or those that support them, are likely to visit when considering if a care facility is right for them.
- Care Home Groups should **prominently** signpost older people in their care to organisations that can <u>either</u> provide some form of formal or informal advocacy, or can provide advice/information/resources on how older people can self advocate.

Introduction:

On 9 November 2022, the National Institute for Clinical Excellence issued guidance on advocacy services for adults with health and social care needs (NG227).

In the NG227 Guidance, NICE asks all those involved with the provision of health and social care sector to,

"Offer advocacy to people who are not covered by the legal entitlement, but who would otherwise not be able to express their views or sufficiently influence decisions that are likely to have a substantial impact on their wellbeing or the well being of someone they have caring or parental responsibility for." [NG227 1.2.1]

18 months after the issuance of the NG227, the Older People's Advocacy Alliance (OPAAL) began conducting a survey of Care Home Groups in the UK, to examine how many Care Home Groups have information on their websites, or, once having been written to, could provide evidence to show that their policies and procedures would meet the requirements of NG227. This report details the findings of those enquiries.

OPAAL's method:

OPAAL used data provided by the website <u>carehome.co.uk</u> to identify care home groups that provide social care services to older people. The decision to focus on care home groups was taken so that OPAAL could assess compliance on NG227 in the widest number of care homes possible.

We conducted an internet review, to see which of the care home groups (listed at Appendix 1) also referenced advocacy in some form. The review was undertaken between 19th June and 20 December 2024.

We followed this basic methodology:

- We looked for care home groups listed on www.carehome.co.uk and checked to see if there was a website listed.
- If there was a website, we looked for an obvious reference to advocacy on that site.
- If we could not see a reference to advocacy, we attempted to find a way to contact the care home group, either an email address or if there was a contact form on the website.

Our method contained the following weaknesses:

- No reference to advocacy on a website, does not necessarily mean that there are no advocacy policies or practices in place for that care home group.
- No response to an enquiry about advocacy policies and procedures does not necessarily mean that there are no advocacy policies or practices in place for that care home group.
- If the contact form on a care home group's website only allowed for a short message, we excluded that care home group from our enquiries.
- A proportion of care home groups do not have a website listed on www.carehome.co.uk.
- A proportion of care home groups do not have a working email listed on their website.

OPAAL's method (cont.):

 A proportion of care home groups only had email addresses for individual care homes, in this instance we emailed just one of the care homes as a representative of the whole group.

Where we found no reference to advocacy at all, we wrote to the care home groups (See message at Appendix 2). We introduced ourselves, explained the concept of independent advocacy, talked about NG 227, and where possible included an article (See Appendix 3) detailing the practical benefits of the application of advocacy. We then asked the following questions:

- Any adjustments you have made to your services in order to inform older people about independent advocacy when decisions are being made about their lives.
- Any additional training you have implemented so that your staff are aware of independent advocacy and can identify when it is needed, and signpost older people to it.

We also offered FREE resources and training aides, to enable organisations to make the necessary changes to incorporate advocacy into their policies and procedures.

Our findings:

Total number of Care Home Group websites reviewed.	515
Number of Care Home Groups that reference advocacy on their website.	1 (0.2%)
Number of Care Home Groups that do not obviously reference advocacy in some form on their website.	514 (99.8%)

Our conclusions:

The findings of our review are really clear. It is very difficult to find a reference to independent advocacy for older people on care home websites OR when contacting a care home group, to get reassurance that independent advocacy practices and procedures are in place.

It is therefore highly unlikely that vulnerable older people in care homes, who may not know about advocacy, and in some instances may not have anyone in their life who can help them speak up about their needs and wants, will get the support they need to fully express themselves about decisions that directly affect the quality of their lives.

This means that the vast majority of Care Home Groups in the UK are not complying with the NICE Guidance NG227.

OPAAL is calling upon all the Care Home Groups in the UK to take the following actions.

- To provide information on independent informal advocacy, what it is, how it could help older people (and others), and how it can be accessed.
- Information on independent advocacy should be provided prominently on the places that older people, or those that support them, are likely to see when dealing with health, social care or housing issues.
- Care Home Groups should provide links to organisations that can either provide some form of informal advocacy, or advice/information/resources on how to self advocate prominently on the pages that older people, or those that support them, are likely to visit when dealing with health, social care or housing issues.

Message to Care Home Groups

We are the Older People's Advocacy Alliance charity (OPAAL) <u>www.opaal.org.uk</u> and for over 20 years we have promoted independent advocacy for older people, particularly at key points in their lives when they face decisions about their health and wellbeing.

The decisions about how we live as we age are crucial to ensuring that we can all enjoy a happy and fulfilling later life. With this in mind, in November 2022 the National Institute for Health and Care Excellence (NICE) issued the following guidance as part of NG227: "Advocacy services for adults with health and social care needs",

"Offer advocacy to people who are not covered by the legal entitlement, but who would otherwise not be able to express their views or sufficiently influence decisions that are likely to have a substantial impact on their wellbeing or the wellbeing of someone they have caring or parental responsibility for." [NG2271.2.1]

As a provider of adult care services, I would be really grateful if you would share any ways in which your network of establishments has changed the way it operates to take account of NG227 including:

- Any adjustments you have made to your services in order to inform older people about independent advocacy when decisions are being made about their lives.
- Any additional training you have implemented so that your staff are aware of independent advocacy and can identify when it is needed, and signpost older people to it.

If for any reason you have not been able to make any adjustments as outlined above, OPAAL is more than happy to provide you with FREE relevant resources and training materials, so that you can easily meet this requirement. This aligns with our charitable objective of promoting independent advocacy for older people.

You may be interested to know that earlier this year we completed a review of how many Local Authorities in England and Wales are signposting independent advocacy to older people at the point of need for health and social care services. You may be as dismayed as we were to learn that a great many older people will struggle to get independent support in making the decisions that best suit them, just when they need it the most. We shared our findings with the CQC, who were very supportive and encouraging in our mission to improve matters.

Hopefully, with your support and the support of other care groups, we can generate some momentum within the care sector, to normalise older people getting help to speak up about their needs and wants if they need it, and thereby ensuring that older people get to live the way they choose in later life.

Making the right choice at the right time

The importance of independent advocacy, information and support for older adults when making decisions about any care needs in later life.

As the numbers of older adults in the UK continues to grow, for everyone to enjoy a happy and fulfilling later life, making the right choices that reflect individualised care and support needs becomes increasingly crucial. Ensuring that each older individual receives the right care, at the right time, requires a system that not only meets any medical and physical needs but also respects the autonomy and personal preferences of that older person. This is why independent advocacy, support, and information play a vital role in any decision-making process about care needs, as highlighted in the National Institute for Health and Care Excellence (NICE) Guidance NG227.

The role of independent informal advocacy

Independent informal advocacy ensures that the voices of older adults are heard and respected when decisions about their care are made. An informal advocate can be anyone the older person chooses, e.g. a family member, a friend, a faith leader, who has the time to listen to the older person's needs and wants and is able to help them express them. For this to be effective however, the advocate must be able to remain totally impartial about any decisions made by the older person.

These advocates can help navigate the often-complex healthcare and social care systems, making sure that older individuals are fully informed about their options and the implications of different choices. This guidance is crucial for making informed decisions that reflect the individual's values and desires. And they can act as intermediaries between the individual and healthcare providers, ensuring that the individual's preferences, rights, and best interests are prioritised.

Some older adults neither need, want, or have access to someone in their circle who is willing and able to act as an informal advocate for them. In these circumstances steps must be taken to support an older individual to advocate for themselves. Self-advocacy is very powerful as it ensures that the older person is always recognised as the expert on themselves. To execute self-advocacy effectively however, some older people may need some different kinds of support, such as note-taking in meetings and/or telephone conversations, information gathering, and additional time for reflection before reaching any conclusions.

The necessity of timely and relevant information

Access to comprehensive information is essential for older adults to exercise their rights and make informed choices about their care. Information should be presented in a clear, accessible manner, considering the potential sensory impairments that can sometimes accompany ageing.

Information is also crucial for families and caregivers, who play a significant role in the support system of older adults. Educating caregivers about the needs and rights of older individuals helps in providing better care and ensuring compliance with the individual's wishes.

It is important to remember, however, that if an older person has been given all the relevant information, had time to consider their options, understood any personal or financial risks that they may be taking, and then decides not to make any changes or to make changes that may appear risky, it remains their right to act in a way that may seem to others to be contrary to their best interests. Whilst this may be hard for others to accept, taking considered risks is a big part of adulthood, and an important factor in ensuring that our autonomy remains intact.

Compliance with NICE Guidance NG227 and Care Quality Commission monitoring

In the NG227 Guidance, NICE asks all those involved with the provision of health and social care sector to,

"Offer advocacy to people who are not covered by the legal entitlement, but who would otherwise not be able to express their views or sufficiently influence decisions that are likely to have a substantial impact on their wellbeing or the wellbeing of someone they have caring or parental responsibility for." [NG227 1.2.1]

With this in mind, the Care Quality Commission has created "People's experience" as a distinct evidence category that they will consider going forwards. This has been designed to identify both good and poor practice when delivering care. Taking account of individual needs and wants is at the heart of that commitment. Providing evidence that an individual has been signposted to independent advocacy or support to self-advocate, will be an important practice for everyone involved in health and social care for older adults.

Conclusion

Independent advocacy, support and information are cornerstones of effective, individualised care for older adults. These elements ensure that older individuals can navigate complex healthcare systems, understand their options, and make decisions that align with their personal values and preferences. Adhering to NICE Guidance NG227 is crucial for fostering a care environment that respects the dignity and autonomy of older adults, ultimately leading to better health outcomes and improved quality of life. As we move forward, it is imperative that healthcare providers, policymakers, and society at large prioritise these aspects to support our ageing population effectively.
